Direct from your account:



1. Online Banking Bill Payment

Go to the website or app for your Canadian Bank, select **Tourism Whistler** as the payee and enter your Member number as the reference.

DO NOT pay the Resort Municipality of Whistler (RMOW) or Whistler Taxes.



2. Interac E-Transfer

Send an e-transfer from your Canadian Bank to twmemberfees@tourismwhistler.com quoting your member number in the comments. This is an autodeposit so no password is required.

3. Annual Pre-Authorized Payment (PAP)

An annual debit on the due date (March 31) from your Canadian Financial Institution.



4. Monthly Installment Plan (MIP)

A monthly debit (on the last business day of the month) from your Canadian Financial Institution. Fees split into 10 monthly payments (Feb - Nov).

5. In person at your bank

Ensure your bank pays **Tourism Whistler** and references your Member number as the account number.



Please ensure your bank **DOES NOT** pay the Resort Municipality of Whistler.



6. Drop off a cheque at Administration

Please drop the cheque in the mail slot next to the front doors at the Tourism Whistler Administration Office. Make your cheque payable to **Tourism Whistler** and write your Member number on the front of the cheque.

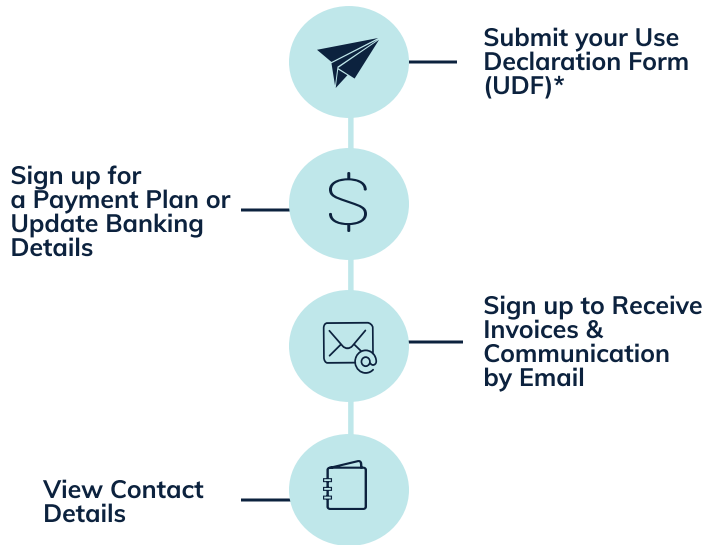
7. Send Cheque by Mail

Make your cheque payable to **Tourism Whistler** and mail it in time to arrive by March 31. Write your Member number on the front of the cheque.

Late Payment & Finance Charges

A 3% penalty will be applied to all accounts that have not been paid in full by March 31 (except those enrolled on MIP). Interest will then accrue on outstanding fees at the rate of 1% per month. Payments that are dishonored e.g. for insufficient funds, will result in late penalties and applicable service charges.

A Certificate of Assessment in Default (CD) will be registered on the title to a property if the Tourism Whistler fees are more than one year in arrears.

Annual Use Declaration Form (UDF)*

If the property is not subject to a restrictive covenant and is not being offered as available for short-term/nightly rentals for more than 14 nights of the calendar year as Tourist Accommodation, the owner may apply each year for the **Residential Resort Lot Rate** by submitting a Use Declaration Form (UDF) by March 31.

If your property will be made **available**** for short-term/nightly rentals for more than 14 nights of the year, then you will need to pay the **Lodging Resort Lot Rate**.

* Not applicable to properties with a registered Phase 2 Covenant or a Restrictive Phase 1 Town Centre Covenant. These properties are always assessed as a Lodging Resort Lot regardless of usage.

**The rate you are eligible for is based on whether the property was available for rent, not whether it was actually rented.
