Residential Resort Lot eligible with completion of UDF declaring no more than 14 nights of availability for Tourist Accommodation rentals	Yes
Permissive Phase 1 Town Centre	Properties located in the Town Centre with a Phase 1 rental covenant, which allows unlimited owner use. When the owner is not using the property, it is <u>not</u> required to be in a rental pool.	Residential Resort Lot eligible with completion of UDF declaring no more than 14 nights of availability for Tourist Accommodation rentals	Yes
Residential Town Centre	Properties located in the Town Centre with no restrictive Phase 1 or Phase 2 covenant with rental pool requirements.	Residential Resort Lot eligible with completion of UDF declaring no more than 14 nights of availability for Tourist Accommodation rentals	Yes
Residential	Properties located outside of the Town Centre with no restrictive Phase 1 or Phase 2 covenant with rental pool requirements.	Residential Resort Lot eligible with completion of UDF declaring no more than 14 nights of availability for Tourist Accommodation rentals	Yes
Not TA Zoned	Properties that are located on Resort Land, but are not zoned for Tourist Accommodation	Residential Resort Lot all the time with no requirement to complete a UDF.	Not required

WHA Resale Value Restricted	Properties located on Resort Land, but resale value is controlled, and ownership/ occupancy is restricted to local employees & retirees.	Tourism Whistler fees are not assessed.	Not required
WHA Occupancy Restricted	Properties located on Resort Land, but occupancy is restricted to local employees & retirees.	Residential Resort Lot all the time with no requirement to complete a UDF.	Not required
Bare Land	Undeveloped land.	Discounted flat rate assessment based on the type of lot.	Not required

Lodging Resort Lot = pays Common and Commercial Fees
